Dr. Robert Claus, United Nations Deputy Chief of Communications, Archives and Records Service, recommended in 1968 that an experienced professional Archivist be appointed, that suitable legislation for the preservation of records be passed and provision be made for a suitable central records repository, and that a small staff be recruited and trained to assist the Archivist. These recommendations have by and large been implemented. Mr. Edward A. Carson, Archivist and Librarian of H. M. Customs and Excise, London, served as Archivist for the year October, 1970 to September, 1971 and was replaced by Mrs. D. Gail Saunders who had trained in Archives Administration and **Records Office Management at University** College, London in 1968 to 1969 and who worked with Mr. Carson for the year 1970-1971. A Trainee Archivist Assistant Miss M. E. Colebrooke, was transferred to the Archives Section in March, 1971 and awarded a United Nations fellowship in November, 1971 for six months at the Jamaica Archives.

The second United Nations fellowship was awarded to Miss Sherriley Voiley who trained for three months respectively at the Jamaica Archives and the Department of Archives, Barbados.

The Public Records Act came into effect in December, 1971 establishing the office to be called the Public Records Office, for which the Chief Justice is generally responsible. The Act was revised in 1987 changing the term Public Records Office to The Bahamas Archives. For administrative purposes, the office is the responsibility of the Minister of Education.

The Archivist under the direction of the Chief Justice is responsible for the day to day running of The Bahamas Archives, the custody, preservation, arrangement, repair and rehabilitation and for such duplication and reproduction of records at The Bahamas Archives, and for the preparation and publication of inventories, indexes, catalogues and other finding aids and guides facilitating the use of such records.

Public Records are not to be made available for public inspection until they have been in existence for thirty years or such other period, either longer or shorter as the Chief Justice specifies. The Public Records Regulations were gazetted in December, 1972.

They made provision for the destruction and disposal of public records and also the fees to be charged for searches, xerox and other copies, made at The Bahamas Archives.

The Archives Section was given Departmental Status under the Ministry of Education and Culture in 1981.

#### RECORDS MANAGEMENT

Mr. Bob Kucera of Blackstock's Equipment Sales, Georgia, visited the Department of Archives from 12 to 16 February, 2000 to design and engineer a multi-level Archives Shelving System, with complete drawings and specifications for the Records Centre. Mr. Charles Conoway, Associate Professor at Florida State University and a lecturer on Records Management visited the Department of Archives 8-11 March, 2000 to discuss a proposed training seminar in Records Management. Mr. Conoway met with Ms. Toote and Mr. Wood and reviewed the department's records management programme. A workshop on Records Management was held 10-12 May, 2000 at the Public Service Centre for Human Resource Development. Mr. Charles Conoway of the Florida Volunteer Corps assisted by Mr. David Wood, Archivist, conducted the workshop. Expenses were funded by the Florida Volunteer Corps.

#### LECTURES, TALKS AND SEMINARS

Dr. Gail Saunders travelled to the U.S. Virgin Islands to attend and give the keynote address at a symposium "From Griots to Archivists: Modes of Historical Memory" from 29-31 March, 2000.

Dr. Saunders was interviewed by Mr. Dwight Glinton for Love 97's programme "For the Love of Junkanoo" on Saturday, 13 May, 2000.

Dr. Saunders, Ms. Turner and Ms. Williams were interviewed by Mr. Max Dean of ZNS, Freeport on historical topics on 22, 23 and 24 May, 2000.

Dr. Saunders spoke on the "Future Directions of Cultural Arts in The Bahamas" at the launching of Yinna Journal of The Bahamas Association for Cultural Studies on 27 July, 2000.

Dr. Saunders gave a talk on "Loyalists and Their Slaves" to students of the DePaul University at the Department of Archives on 6 December, 2000.

#### **Antiquities Corporation**

The Minister of Education approved the Museums Corporation, Board of Directors, including a chairman and deputy chairman. Additionally, efforts to identify suitable staff, equipment and adequate accommodation commenced. Preparatory measures for the establishment of a **National Register of Historic Resources** were implemented. The Corporation is awaiting Cabinet decision for New Plymouth, Abaco and Dunmore Town, Harbour Island to be declared historic districts. The Corporation continued to identify suitable staff, equipment, and adequate accommodations. The building in the same complex as the Pompey Museum was designated for the administrative offices of the Antiquities Corporation. In that regard, the roof was repaired.

#### **Pompey Museum**

The need for additional offices at the Pompey Museum, for corporation staff required that the Gallery space that exhibits the Amos Ferguson collection was reduced.

#### **Balcony House Museum**

The staff of Balcony House was officially transferred from the Central Bank to the Department of Archives with effect from January 2000. A draft contract between the Corporation and the Bank regarding the turnover of the House was prepared for consideration. Also, talks were held with the Ministry of Tourism regarding marketing ideas for Balcony House. In January 2000 a team of officials from the Ministry of Education and Youth, led by Minister of State for Education, the Hon. Zhivargo Laing, and accompanied by the Director of Archives visited the Pompey Museum and Balcony House. The officials were impressed with the condition of the House and the performance of the tour guide.

#### Long Island

Dr. Tinker and Mrs. Kim Outten Stubbs visited the Long Island Museum along Ms. Nellie Brennen (Ministry of Education Library Services) in February 2000. The team met with Mr. Larry Cartwright who was identified to work in the Long Island Museum. Plans to procure appropriate furnishing, such as exhibit display cases and artifacts for exhibition were discussed. Hours of operation, general maintenance and administration were also discussed.

#### San Salvador

An effort was initiated to re-open the public museum. A new museum committee comprising the administrator, Head of Local Government and Dr. Gerace, was established. The committee is to oversee the upgrade of the facility and the exhibits. Preparations were made for the completion of the archaeological work begun at the Columbus Landing Site. Negotiations between the Department of Archives and the Ministry of Tourism to establish a tourism information desk on the museum compound was initiated.

#### Bimini

The Prime Minister Ingraham gave an address at the official dedication of the Bimini Museum on Saturday, 29 January, 2000. The museum is housed in a restored building originally constructed in the 1920s, which previously housed the Commissioner's Office, the jail and other government offices. The project was a community effort, spearheaded by Sir Michael and Lady Checkley and was privately funded over a period of eight years. The project cost \$100,000.00. Dr. Saunders, Director of Archives also attended and gave brief remarks.

#### Fort Charlotte

Restoration and refurbishment work continued at Fort Charlotte with the electrification and the installation of a generator. A private security firm was hired to protect the Fort from burglars. Lights were installed to provide additional security. Since the lights were installed in the perimeter areas, two lights were damaged.

The staff continued to press for additional support staff since the retirement of Messrs. Gittens and Johnson created a staff shortage. Mr. Johnson agreed to assist on a volunteer basis. Two courtesy guides from Fort Fincastle were identified as a replacement. However, word from the Department of Public Service is forthcoming.

The two vendors housed on the walk path continued to pose a problem. Efforts to have them removed continue.

#### Fort Fincastle

The courtesy guides at the site continue to pose disciplinary problems, especially through infighting, alcoholism and the "hustling" of visitors. Efforts continue to systematically discipline and/or remove the more problematic guides and to properly train and monitor the others. The Ministry of Tourism held an in-house training seminar for the courtesy guides then presented them with uniforms.

The Cabinet approved an estimated \$200,000 to improve the environs at Fincastle. Ms. Alicia Oxley, Ministry of Public Works historic architect was assigned to oversee the improvements,

which were to include refurbishment of the waterfall and restoration of the Queen's Staircase. All vending stalls in the ravine were relocated to a more suitable area. Consultants Mr. James Levy, Historic Conservator with the State of Florida, visited the Corporation to advise on the set up of a conservation lab.

Consultant Herbert D. Bump also came in under the Florida Volunteer Association Corporation sponsored programme.

UNESCO provided a grant for the cleaning of the Queen Victoria Statue that was vandalized in late November 1999. The project was completed by 26 February, 2000. The restored statue was unveiled to the public on 28 February. This project was executed by Bahamian, Mr. William Adderley.

#### **EXHIBITIONS**

The Department of Archives did not mount an annual exhibition in the year 2000. However, a small display on the Department of Archives and its functions was mounted for the job fair held at the College of The Bahamas.

ORGANIZATION OF AMERICAN STATES (OAS) GRANTS

The final phase of the OAS project for the Dissemination of Cultural Information

throughout The Bahamas was completed in the year 2000. Two teams of archivists visited five Family Islands viz: Long Island, San Salvador, Grand Bahama, Cat Island and Acklins, Crooked Island and Long Cay. Workshops were held at a total of eight schools and literature distributed to the BJC and BGCSE students.

Ms. Elaine Toote, Ms. Patrice Williams and Ms. Sherrine Thompson travelled to Long Island 6-8 March, 2000 to disseminate cultural information to high school students. They addressed the students on "The History of The Bahamas" and showed the video "Heritage, History and Culture." The same officers visited San Salvador 27-29 March, 2000 for the same purpose. They made themselves available to answer questions regarding the B.J.C. and B.G.C.S.E. History and Social Studies projects. In addition, the officers took a selection of Archives Exhibition booklets for distribution to the students. The ongoing programme is funded by the Organization of American States.

Dr. Gail Saunders, Mr. Jolton Johnson and Mr. David Wood visited Crooked Island, Acklins and Long Cay 21-25 March, 2000 to execute the above programme.

The team of Ms. Elaine Toote, Ms. Patrice Williams and Ms. Sherrine Thompson visited Grand Bahama between 19-21 June to execute the OAS Project to disseminate cultural and historical information. They met with the Social Studies teachers and gave them information with regards to the BJC and BGCSE Curricula.

The team comprising Dr. Gail Saunders, Mr. Jolton Johnson and Mr. David Wood visited Cat Island between 27-29 June, 2000 to conduct the above project. They lectured to students in Arthur's Town High School and The Bight High School and showed the video "Heritage, History and Culture." Several persons were interviewed. They also visited the Deveaux House ruins and checked on government records at the Administrator's Office.

The Department also received another grant from the above-mentioned institution in December 2000. The project for Strengthening Public Institutions in the management of historical and cultural material throughout the Family Islands will be executed in 2001.

#### **UNESCO GRANT**

This year the Archives also received a substantial grant from UNESCO. The funds will be used in the area of training and will be executed over a two-year period, beginning in 2001.

#### **MAINTENANCE**

The Ministry of Public Works cleaned the grounds of the main complex on Mackey Street on a monthly basis.

#### INTERNATIONAL COMMUNICATION

Dr. Gail Saunders attended the 32nd Annual Conference of the Association of Caribbean Historians in Cayenne, French Guiana between 17-21 April, 2000. At the conference she chaired a panel discussion, the second part of the Annual General Meeting and an Executive Committee Meeting after being elected as President of the Association of Caribbean Historians. The next conference is scheduled for Trinidad and Tobago at the beginning of April, 2001. The Executive Committee meets in Puerto Rico in late October. The College of The Bahamas has verbally accepted the invitation to host the Association of Caribbean Historians Conference in 2002.

Ms. Elaine Toote, Deputy Director and Ms. Patrice M. Williams, Assistant Director of Archives travelled to Paris between 1-12 May, 2000 to conduct research in the Diplomatic Archives and National Archives of France. The purpose of the research was to identify records pertaining to the Bahamas that are being held in these two institutions.

While in Paris documents relating to the French control of Turks and Caicos Islands and Inagua in 1764 were identified. In addition original documents regarding Cardinal Richleu's grant of Abaco, Inagua, Mariguana and Guanahani, Islands in The Bahamas to Guillaume de Caen in 1633 were also located. Of similar importance was the discovery of the manuscript of M.M. Bellin's account 1758, which included a section on The Bahamas. Copies of the documents identified are being copied onto microfilm to be purchased by the Department of Archives. Attempts are being made to identify a researcher based in Paris to continue the research.

The realization of this trip was within the frame work of the bilateral agreement between the French and the Bahamas governments. Funding was secured through the Bahamas government, the French government and the "Friends of The Archives."

Alliance Francaise des Bahamas assisted as the liaison institution between the Charge d'Affaires in Santo Domingo and the Department of Archives.

Ms. Toote and Ms. Williams attended the XIV International Congress on Archives (ICA) in Seville, Spain from 21 to 26 September, 2000. The theme of the Congress was Archives of the New Millennium in the Information Society.

Over 3,000 Archivists from around the world attended the Congress. During the intense four days, papers were given on various topics including Archival Science, developing a training model for Archival Science, Preservation programmes in Natural Disasters and the ISAD(G) Standards.

The highlights for Ms. Toote and Ms. Williams were the presentation of the revised version of the General International Standards of Archival Description (ISAD(G) and the session of the Application of Quality Management in Archives. These were very important as they embodied many of the principles now practised in the department. It was reiterated that the ISAD(G) standards were to be used along with each country's national standards and that they would be updated every four years in order to keep abreast of electronic and professional changes.

The 15th International Congress on Archives (ICA) will be held in Vienna, Austria from 23-28 August, 2004 under the theme "Archives, Memory and Knowledge."

Dr. Saunders, Director of Archives and President of the Association of Caribbean Historians attended a meeting of the Executive in San Juan, Puerto Rico between 27 and 29 October, 2000.

Ms. Elaine Toote attended an executive meeting in the Caribbean Association (CARBICA) from 27 November to 1 December, 2000 in St. Vincent. While in St. Vincent members of the executive were able to attend the opening of the second National Archives Week and meet with the Permanent Secretary responsible for the National Archives. This was very beneficial as issues concerning the improvement of the National Archives in St. Vincent was discussed.

Ms. Toote informed members that CARBICA was attempting to meet in Caribbean countries which have less developed archives.

### PUBLICATIONS AND PUBLIC RELATIONS

Four archival booklets which had been out of print for many years were reprinted by the Department's Publication Section. They are: The Pineapple Industry, The Sponging Industry, A Guide to African Villages and A Guide to Selected Sources for the History of the Seminole Settlements at Red Bays Andros 1817-1980. A booklet on the Department of Archives and its function was also printed this year. In addition, an English firm by the name of Oxford Maritime Press printed the exhibition booklet Highlights in the History of Communication in The Bahamas 1784-1956 free of charge.

#### THE NATIONAL ART GALLERY

The contract for the restoration of Villa Doyle, which will house the National Art Gallery, was approved by the Tenders' Board and the Cabinet.

The contract was awarded to Reginald Hunt Construction Company. An official contract signing was held on Friday, 25 February, 2000 at 11 a.m. when the Prime Minister gave the keynote address.

Dr. Jane Bedno, Consultant, Museum Designer and Director of University of the Arts, Philadelphia under the sponsorship of the Inter-American Development Bank visited Nassau to consult with the National Art Gallery Committee and also the Museums Section, Department of Archives. She submitted a report to the Committee making recommendations on technical matters. She also recommended that the ballroom be turned into a period room of the 1920s, an interior designer be contracted to work with the Architect and Contractor and a Consultant Director be appointed as soon as possible.

The National Art Gallery Committee agreed to contract Mrs. Beverley Nairn, Interior Designer of CBN Interiors. A draft advertisement has been forwarded to the Department of Public Service via Ministry of Education and Youth for a Consultant Director of the National Art Gallery.

The National Art Gallery Committee met regularly in 2000. It has identified a Consultant to provide a collections' policy and make recommendation for the administrative structure of the National Art

Gallery of The Bahamas. The Committee is in search of a Consultant Director to assist in establishing the Gallery. The Committee feels that this consultant will assist in helping us to move forward. The Director of Archives, who is Chairman of the National Art Gallery Committee, attended a meeting on 11 December, 2000 called by the Minister of Works, Mr. James Knowles. The restoration project is three months behind schedule. The building is due to be completed by mid-July, 2001.

#### **AUTOMATION**

Some work was done on the automation project by two teams. However, further effort was stifled because of the need for a backup system to record the work done and the fact that the people involved in the venture were caught up with other urgent projects. Work is expected to resume in the year 2001.

A web site on the Department of Archives (www.bahamasnationalarchives.bs) that was designed in-house, has been launched on the Internet. It shows the functions of the Archives and indicates which services are available to researchers.

ASSOCIATION OF CARIBBEAN UNIVERSITY RESEARCH AND INSTITUTIONAL LIBRARIES (ACURIL) CONFERENCE

Four (4) members of the Department of Archives, Ms. Patrice Williams, Ms. Sherrine Thompson, Ms. Joycelyn Rolle and Mrs. Queenie Butler were involved in the ACURIL Conference held during the week of 4-9 June, 2000 at the Radisson Cable Beach Hotel. Ms. Williams, Thompson and Rolle were a part of the Exhibits Subcommittee while Mrs. Butler was involved with the protocol committee. Arrangements were made for two members of staff to attend the sessions each day.

### ADVICE GIVEN TO ROMAN CATHOLIC ARCHDIOCESE

The Director of Archives met with Father Joe Perna and His Grace The Archbishop Burke of the Archdiocese of the Roman Catholic Church in the Bahamas on 1 November, 2000. She offered advice on setting up a small archives.

VISIT OF RT. HON. LORD WOOLF, CHIEF JUSTICE OF ENGLAND AND WALES AND LADY WOOLF TO THE ARCHIVES

The Rt. Hon. Lord Woolf and Lady Woolf visited the Department of Archives on 12 December, 2000. Mrs. Willamae Salkey, the Permanent Secretary was also in attendance. The Director of Archives welcomed Lord and Lady Woolf and presented Lord Woolf with a bound collection of the Department's publications. Lord and Lady Woolf were then taken on a tour of the Research Room, the Repositories, the Repair-Bindery, the Microphotography Section and the Records Centre. They were highly complimentary of the Department of Archives and the government for having the foresight in the area of preservation.
